Many families and communities have struggled to live from day to day. Progress has been slow and painful—from not believing that education was for them, to, after more than 20 years, declaring that education is their inalienable right.

From labourers to farmers, and from women who seldom left the house to those now voicing their demand for equal recognition in education and a dignified, safe life free from violence.

Persons and children with disabilities were once unseen and unheard. Now, they are demonstrating their abilities and capabilities like others in society, with the right to the same opportunities in life.

55 years ago, mothers could only pray for a safe delivery. Today, they have access to government, private, and RDT Hospital facilities for a safe pregnancy, delivery, and a healthy baby. RDT has grown from a small group of motivated individuals determined to support vulnerable communities in achieving a dignified, equal life, to a competent, respected development organisation in the states of Andhra Pradesh and Telangana. It has consistently supported people across all areas of development for 55 years.

Fifty years ago, Anantapur was a dry, semi-arid land with little vegetation. Today, though still a dry region,

it has seen significant progress through collective efforts—hillock and wasteland reforestation, horticulture, diversified crops, and many farmers adopting organic farming and drip irrigation.

Girls and boys who once struggled to reach 10th class are now selecting universities and professional courses for higher studies, securing well-paid jobs. We're also really proud of the many talented girls and boys who have put Anantapur and Andhra Pradesh on the map of sports excellence, winning medals and representing their district, state, and country. We're especially proud of the youngsters from Anantapur who have consistently been selected for the Special Olympics, always bringing home gold, silver, and bronze medals.

RDT is motivated and ready to move forward into the next decade—supporting people, collaborating with government programmes, and working alongside other like-minded organisations to create a better life for all. We are also aware of the grave threat that climate change poses to us all, and we are ready to face this challenge by doing our part to foster a cleaner, healthier environment.

I thank all of you who have been part of our 55-year journey and who have helped make all of this possible.

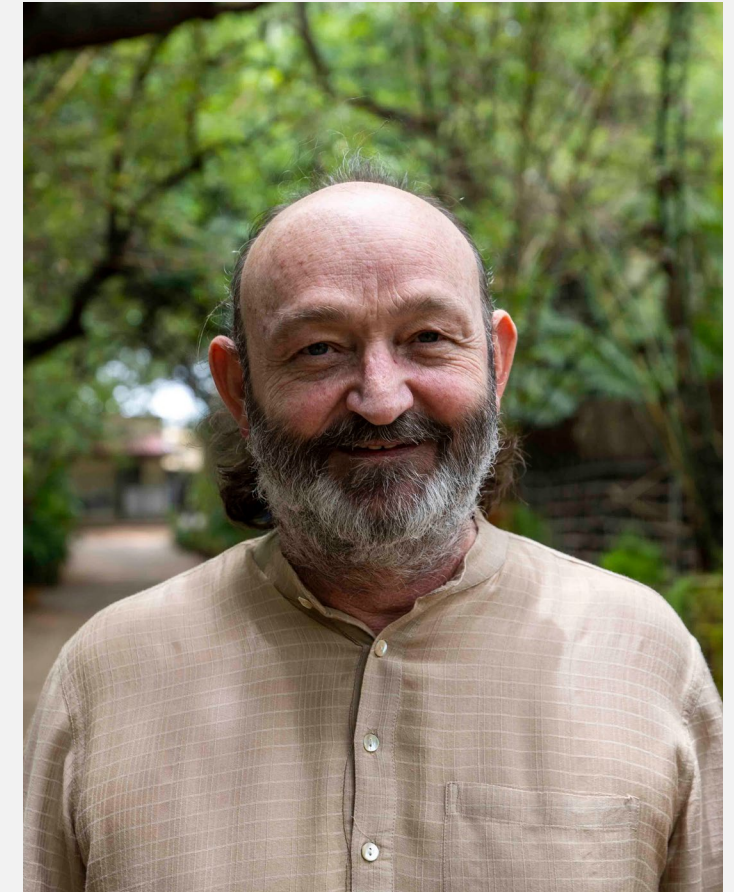

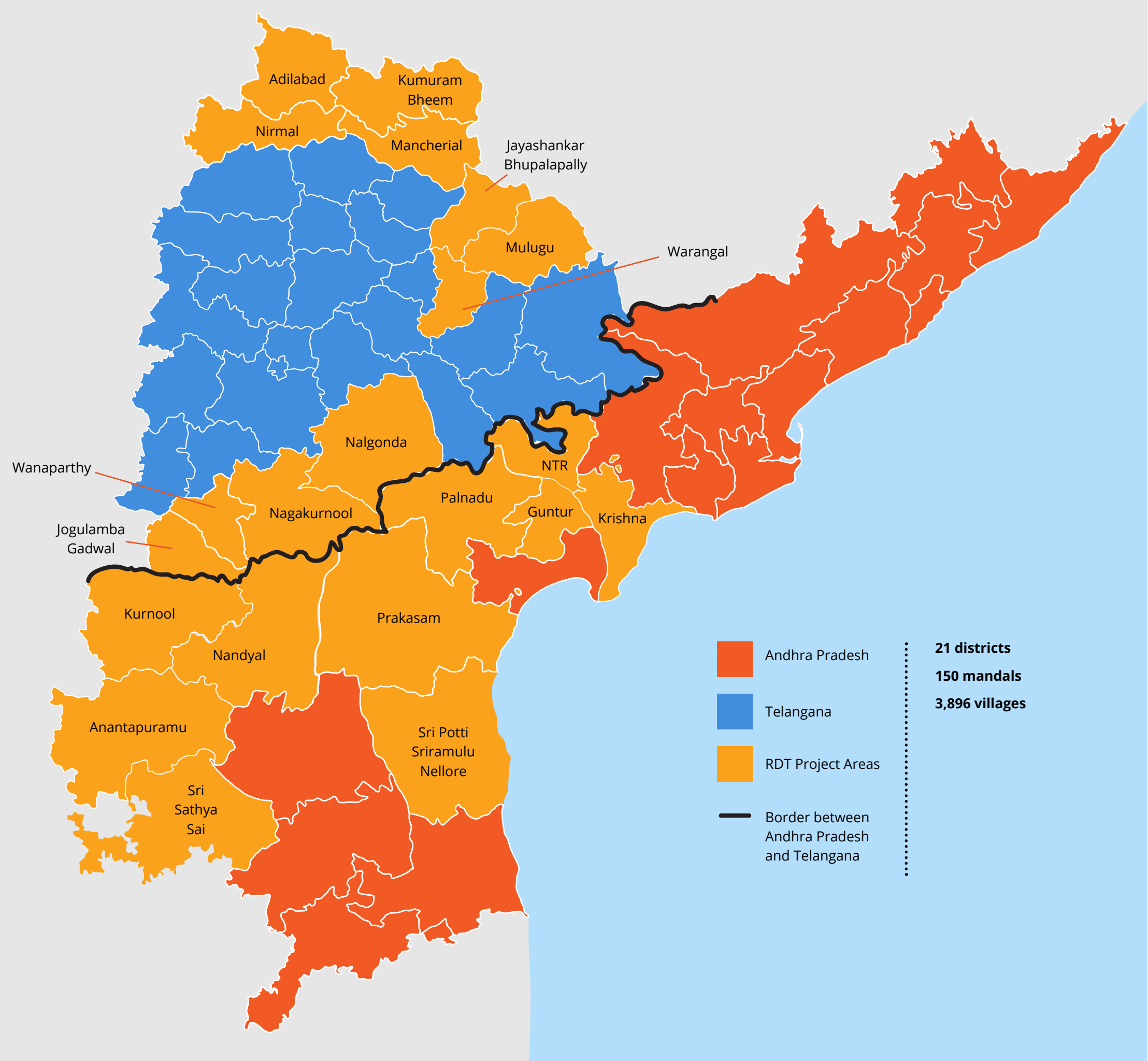

EQUALITY

EQUIPPING WOMEN WITH ACCESS TO EQUAL OPPORTUNITIES, RESOURCES AND ENABLING THEM TO DRIVE CHANGE WITHIN COMMUNITIES.

Sustainable development is achievable when women are recognised as equal stakeholders in the progress of their communities. In 2023-24, through 8,534 Women Sanghams, 89,994 women were equipped with leadership skills and enabled to bring change in their communities through peer support and collective action.

Through the RDT Professional School for Foreign Languages, 361 women gained employment, enhancing their skills and accessing equal opportunities in the competitive workforce. 1,215 Supplementary Schools provided 27,042 girls with foundational education, ensuring they are prepared for a brighter future. Additionally, by combining academics and sports, 8,644 girls participated in grassroots sports programmes across sporting disciplines like Cricket, Football, Basketball, Hockey, Judo, Softball, Kabaddi, Archery and Athletics.

INDEPENDENCE

SUPPORTING WOMEN WITH OPPORTUNITIES TO PAVE THE WAY TOWARDS DIGNITY AND SELF RELIANCE.

Economic independence of women is essential for the development of communities. In 2023- 24, through over 50 different Income Generation Programmes such as book binding, kalamkari centres and sanitary napkin centres and others supported 33,648 women in establishing small-scale businesses.

16,423 women received assistance to pursue graduation and post graduation through RDT Education Programmes. Through the support of 8,534 Mini Banks, women were not only provided with financial inclusion but also positioned as leaders within their communities, driving collective progress.

SAFETY

PRIORITISING SAFE ENVIRONMENTS THAT SUPPORT WOMEN'S ACTIVE PARTICIPATION AND GROWTH.

Addressing the fundamental need for safety and dignity, till 2023-24, 87,032 houses were constructed under RDT's Dignified Housing Programme, with 93% of new homeowners being women. With the support of 14,624 trained network leaders across 1,424 villages, women's participation in decision-making processes was ensured. Through 15,115 institutional deliveries and 2,67,303 women treated across G&O services within the RDT Health Network, timely maternal and essential healthcare reduced risks and improved healthcare outcomes. 974 women accessed counselling services through 21 RDT counselling centres, enabling them to navigate challenges and building secure environments.

OUR APPROACH

RDT works to ensure access to quality and affordable healthcare by addressing the accessibility gap in medical services. Through a network of 3 rural hospitals, 3 rural clinics, and 2 mobile clinics, RDT brings essential healthcare services closer to those in need. Emphasising the importance of preventive health, RDT conducts regular screenings, immunisation drives and health education initiatives, enabling individuals to make informed healthcare decisions.

ACCESSIBILITY

IMPROVING ACCESS TO QUALITY AND ESSENTIAL HEALTHCARE IN RURAL AND REMOTE COMMUNITIES

Access to affordable healthcare remains a cornerstone of well-being. In 2023-24, 8,19,835 people accessed affordable healthcare through the RDT Hospital Network, including 2,762 newborns admitted to specialised NICU care. Through our mobile clinics in tribal communities in Srisailam, we reached 23,349 individuals and provided essential healthcare, ensuring timely medical support. 3,325 aids and assistive devices were provided to persons with disabilities enabling their autonomy. 10,088 surgeries were conducted across RDT Healthcare Network ensuring access to timely care and medical rehabilitation.

Additionally, 728 children were actively involved in the Early Intervention Programme, identifying disabilities in children and offering timely care and support.

AWARENESS

WORKING TOWARDS COMMUNITY HYGIENE, HEALTH AND WELLBEING THROUGH AWARENESS

In 2023 - 24, RDT conducted 345 general awareness camps across RDT work areas to create awareness in communities on various healthcare issues. 492 awareness programmes were held throughout tribal regions to encourage early diagnosis and detection of symptoms and informed decision making. 7,883 adults and 4,789 children in 231 villages were provided with nutrition, emphasising anaemia prevention and fulfilling dietary needs. HIV Counsellors and Health Organisers raise awareness in villages, providing support for patients with infectious diseases and other ailments. Additionally, 8 reverse osmosis plants were installed to ensure clean water access, and 2,337 bathroom cum toilet facilities were constructed in 2023-24 to promote hygiene and well-being.

ASSISTANCE

MAKING QUALITY MEDICATIONS, SERVICES, CHECKUPS AFFORDABLE FOR ALL AND ENSURING INDIVIDUALS RECEIVE THE RIGHT CARE THROUGH TIMELY REFERRALS TO ADVANCED MEDICAL INSTITUTIONS.

Critical illness demands specialised care. In 2023-24- 1,416 individuals were referred to advanced institutions for treatment. Through the Paediatric Cancer Project, RDT supported 72 children in their fight against cancer, providing families with guidance and access to better healthcare. The Department for Infectious Diseases at RDT Bathalapalli Hospital currently serves 7,943 patients registered under ART Therapy, achieving 97% adherence rate. In 2023-24 - 3,044 single mothers accessed check-ups and medical assistance.

COMMUNITY

CREATING AWARENESS AND SUPPORTING COMMUNITIES IN MOVING TOWARDS A SUSTAINABLE FUTURE.

Community led actions enables ownership, making solutions more sustainable and impactful. Through interactions and deliberations at the local level, 166 Ecology Development Committees (EDC's), 1,129 EDC leaders played an integral part in addressing local problems and promoting sustainable practices. Through 200 awareness sessions for 12,774 members in EDC committees, we ensured that farmers were able to adopt organic farming practices. Additionally, in 2023-24, a total of 1,960 individuals participated in awareness sessions as part of the Mana Bhoomi Initiative and were encouraged to reduce plastic usage and adopt eco-friendly alternatives.

SUSTAINABILITY

PROMOTING AND ENSURING ECONOMIC AND ENVIRONMENTAL SUSTAINABILITY AT ALL LEVELS.

Sustainable practices ensure the resilience of both communities and natural resources for generations to come. To mitigate drought prone conditions in Anantapur District and surrounding areas, over the years, 1,376 check dams constructed and 25,997 farmers adopted micro irrigation practices. In 2023 - 24, 7 percolation tanks were constructed, 308 farm ponds were restored to conserve water, and 670 sprinkler systems were provided to farmers. Through management of essential resources, we were able to irrigate 5,059 acres of land in 2023-24, across Andhra Pradesh and Telangana. 300 Animal Vaccinations were conducted during the period, providing sustainable income and complementing farming practices.

FUTURE

ENSURING SUSTAINABLE FARMING PRACTICES AND INTEGRATING RENEWABLE ENERGY AND BIODIVERSITY FOR A SUSTAINABLE FUTURE.

We are committed to a sustainable future that ensures resources for future generations while ensuring a healthier environment. In 2023-24, RDT distributed 2,95,936 fruit saplings to farmers, planted 3,99,367 saplings, and developed 12 kilometers of avenue plantations, enriching biodiversity and expanding green cover. This year, we supported 58 new villages in transitioning to organic agriculture. To promote crop diversity, we provided 850 kilograms of Hamata forage seeds to local farmers. Additionally, we have distributed 614 solar panels over the years, advancing the use of renewable energy and equipping farmers with sustainable solutions for the future.

CHILD PROTECTION & EDUCATION



TO ENSURE THAT CHILDREN AND ADOLESCENTS WITH AND WITHOUT DISABILITIES REACH THEIR FULL POTENTIAL THROUGH ACCESS TO EDUCATION, A SAFE ENVIRONMENT AND EQUAL OPPORTUNITIES, ENABLING THEIR HOLISTIC DEVELOPMENT.

OUR APPROACH

RDT aims to bring out the full potential of every child by providing them equitable access to resources. RDT works with children with and without disabilities by creating access to quality education through supplementary schools and scholarships, ensuring security of children in need through shelter homes, while enabling children to exercise their right to play and accompanying them in paving paths to brighter futures.

EQUIP

CREATING ACCESS TO EDUCATION AND LIFE SKILLS FOR CHILDREN AND ADULTS FOR A BETTER FUTURE.

Through the RDT General Support Programme and RDT CET Scholarship programme 11,571 children have gained access to higher education till 2023-24, this helped them access professional courses and training opportunities bridging the gaps. Annually, 3400+ students appear for the RDT CET Exam. Till date, through this programme 1,185 students are on the path of becoming doctors, engineers and more. Beyond academics, 14,006 children participated in RDT's sports programmes, enabling teamwork, discipline, and confidence. Additionally, by distributing 43,142 bicycles we ensured students have reliable transportation to complete their education without disruption.

DEVELOP

PROMOTING HOLISTIC GROWTH BEYOND ACADEMICS AND SUPPORTING COMPREHENSIVE DEVELOPMENT THROUGH DIVERSE SKILL BUILDING OPPORTUNITIES

The evolving educational landscape requires innovative approaches to prepare students for future challenges. In 2023-24, 86% of students in RDT Professional School of Foreign Languages found a job through the courses that focused on employment readiness, language and skill building. Employment opportunities were secured by 148 PWDs ensuring that they achieve independence through work. Through the Mobile Libraries Project, we were able to reach 83,725 readers in 32 villages and cultivating reading habits in both adults and children. Through Youth Development Programme in Sports 83 Youth were trained in refereeing, coaching and leadership.

EDUCATE

IMPROVING EDUCATIONAL OPPORTUNITIES AND OUTCOMES AND EQUIPPING STUDENTS WITH SKILLS TO PURSUE HIGHER EDUCATION.

Quality education is essential to ensure improved educational outcomes and development of children. Through 1,215 supplementary schools across Andhra Pradesh and Telangana, RDT supports 54,926 students, ensuring they get additional tuition to improve their learning. RDT's initiatives for children with disabilities include 16 educational and rehabilitation centres catering to the diverse needs of children with a broad range of disabilities. Through these holistic efforts, we aim to support children to chart their unique paths and envision a future full of possibilities. Through the participation of 18,839 individuals through Community Development Committee workshops, we were able to reach out to communities on the importance of education.

EQUITY

EQUIPPING FAMILIES FOR A SECURE FUTURE, CREATING EQUITABLE ECONOMIC OPPORTUNITIES ACROSS GENERATIONS.

At the heart of social development lies the ability to create self-sufficient communities, where individuals have the tools and opportunities to contribute to society and themselves. RDT enabled 12,088 PWDs to access employment through MGNREGS cards, ensuring financial inclusion and dignity. Income generation programmes supported 39,571 women and persons with disabilities and supported them to live their life with respect and autonomy.

CHANGE

EQUIPPING SELF HELP GROUPS WITH REQUIRED KNOWLEDGE AND SKILLS AND ENCOURAGING THEM TO ACTIVELY ENGAGE IN COMMUNITY DEVELOPMENT.

Change begins when communities come together to address shared challenges. Through 1,976 Vikalangula Sanghams, RDT reached 25,355 individuals, enabling them to identify and resolve local issues collectively. 16,931 individuals attended workshops on leadership and business management equipping them with skills to communicate effectively and lead their communities.

DIGNITY

CREATING SPACES FOR COMMUNITIES AND INDIVIDUALS TO GROW TOGETHER THROUGH ESSENTIAL INFRASTRUCTURE, INCLUDING DIGNIFIED HOUSING, WATER AND SANITATION.

By identifying community-specific challenges, RDT has supported communities in improving living conditions through the construction of 87,032 houses, 111 water purification plants, and 58,241 bathroom-cum-toilet facilities as of 2023-24. Over the years, 53 villages have been provided with electricity, significantly enhancing their quality of life. Additionally, in 2023-24, 24 community centres-cum-Anganwadis were built, creating spaces for education, growth, and collective engagement.

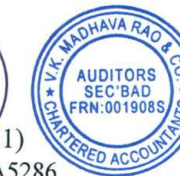
